Wisconsin Christian Expo reserves the right to select the slate of performers, entertainers and his/her groups and to assign the days and times. Applicants who are not accepted will be notified and their application fee will be refunded.

Wisconsin Christian Expo will provide a 10' x10' stage with 4 microphones, amplified speakers, stage monitors, and mixing board. A sound engineer will be provided and will be the only person authorized to operate the sound system. A table for the sale of merchandise will also be provided.

Performers, entertainers and his/her groups are responsible for transporting all of their equipment to the stage, as no loading dock or staff will be provided for this purpose. Including set-up and tear-down, performers, entertainers and his/her groups will be allotted 1 hour on the day or days of performance. Wisconsin Christian Expo is not responsible for any lost, damaged, or stolen property, nor is it liable for any injury to persons participating in the Wisconsin Christian Expo or its related events.
